## **APPOINTMENT OF SERVICE PROVIDER TO SUPPLY, INSTALL AND COMMISSION A NEW AUTOMATIC VOLTAGE REGULATOR SYSTEM AT THE AGRIZONE REF NO.: DTP/RFP/24/AGZ/01/2017**

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC AgriZone has a varying voltage network which supplies power to sensitive electronic equipment and machinery and thus would require an Automatic Voltage Regulator to be installed to supply constant clean power.

In order to achieve this, DTPC invites proposals from a competent service provider to supply, install and commission a new Automatic Voltage Regulator system at the AgriZone located within Dube TradePort Precinct.

The contract will have an element of Enterprise Development (ED) of a minimum of 30%. This is to be executed by historically disadvantaged companies which have at least 51% black owned. The ED element is designed to assist with the development and sustainability of black companies (i.e. EME and QSE) through participation and development within this contract.

## **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system.
